Bill 137

- -Changes to the Education Act
- -Consent for change to gender identity 197.4
- (1) if a pupil who is under 16 years of age requests that the pupil's new gender-related preferred name or gender identity be used at school the pupils teacher and other employees of the school shall not use the new gender related preferred name or gender identity unless consent is first obtained from the pupils parent or guardian.
- (2) if it is reasonably expected that obtained parental consent as mentioned in sub section (1) is likely to result in physical, mental or emotional harm to the pupil the principal shall direct the pupil to the appropriate professionals, who are employed or retained by the school, to support and assist the pupil in developing a plan to address the pupils request with the pupil's parent of guardian.
